Sub: Engagement of Graduates and Diploma Holders as Apprentice Trainees in the Karnataka Government Secretariat Library, under the Apprenticeship Training Scheme of The Apprentices Act, 1961 regarding.

PREAMBLE:

In the Government Order read at (9) above, sanction was accorded for the engagement of Graduates/Diploma Holders in Library and Information Science and Diploma Holders in Commercial Practice as apprentices in Karnataka Government Secretariat Library under the Apprenticeship Training Scheme of the Apprentices Act, 1961 for the year 2017-18. Accordingly, Apprentice trainees have been appointed for a period of one year. On completion of this one-year training period, the trainees are relieved from the Karnataka Government Secretariat Library. The rates of stipend to be paid to the Apprentices have been revised in the Government order read at (5) above. It is now proposed to continue this Apprenticeship Training Scheme for the year 2018-19.

The Director, Board of Apprenticeship Training (Southern Region) Government of India has agreed for the engagement of twelve degree holders in Library and Information Science, Ten Diploma Holders in Library and Information Science, and Two Diploma Holders in Commercial Practice as apprentice Trainees under the Apprentices Act, 1961.

The proposal has been examined and the following orders are issued.

Sanction is accorded for engagement of Graduates and Diploma Holders as apprentices under the Apprenticeship Training Scheme in Karnataka Government Secretariat Library as detailed below on a monthly stipend of Rs.10,000/- (Rupees Ten Thousand Only) in case of Graduates in the field of Library and Information Science and Rs.8,000/- (Rupees Eight Thousand Only) in case of Diploma Holders in the field of Library and Information Science/Commercial Practice for a period of one year during 2018-19.
